SUBSTANCE ABUSE...IS THERE ANYTHING NEW?

Donna Gorman graduated from Pacifica Graduate Institute with a Masters in Counseling Psychology in 2002. Her graduate work was strongly influenced by her affinity for Jungian and Existential ideologies and her commitment to help others to understand their difficulties within the context of psychological maturation and personal development.

Donna has worked in the field of substance use since 1998 in a variety of settings including men's long-term residential treatment, outpatient services, and the Criminal Justice System as a supervisor. She has also taught in a Physician's Assistant Program in the City Colleges of Chicago. Donna is currently Program Manager at Healthcare Alternative Systems (HAS) in Wheaton. Her therapeutic approaches include a broad range of Cognitive-Behavioral techniques and Mindfulness practices. She is a certified Yoga instructor, long-time meditator, and a competitive equestrian.

Vanessa Hernandez completed her BA in Human Services at National Louis University, and currently is enrolled at Aurora University in the Masters of Social Work program. Vanessa was born and raised in Peru, and has been in the US since 2003. She has worked as a counselor at Healthcare Alternative Systems (HAS) since 2010 focusing on assessments, adult and youth intensive outpatient, outpatient, and DUI services. In addition, Vanessa has piloted a program for adolescent girls and oversees HAS' PAD Project, which involves a weekly support/education group at HAS. This program also includes home visits with highly resistant, dual-diagnosed individuals living in supportive housing through DuPage PADS. As a bilingual worker, Vanessa also works with all of HAS' Spanish-speaking referrals, as well as some refugee clients from other countries. Vanessa is a trained doula, and is working toward becoming a Trauma-Certified Professional.
